

In Memoriam of Michael Spitz

#### Michael Spitz 1987-2022

We recently learned of the sad passing of a Political Science graduate student who was on leave from his studies at UC Irvine, but still a valued friend and colleague to many. Michael Spitz, who joined the department in 2018, passed away in a rock climbing accident in Joshua Tree National Park on January 16, 2022.

Michael's research included an area specialization in Mexico, public policy, labor movements, and resistance. He exemplified what it meant to be a scholar-activist, as he worked and served in the communities he dedicated himself to within the academy. Even while on leave from the department, he devoted himself to academics as a teacher at Santa Fe Christian School in Solana Beach, where he taught Spanish, AP courses, and was the surf team coach.

Michael was an avid outdoorsman, spending every spare comment climbing, surfing, backpacking, and skydiving. He encouraged his cohort and all around him to get outside, enjoy nature, and balance their work-life by pursuing their passions.

Michael leaves behind a legacy of intellectual generosity and community building that will live on in this department by those who knew him.
